Don't be afraid to go Minus! Bid vulnerable games at imps! If only 4/10 games which you bid actually make, you will come out ahead winning 10 imps four times (620-170=450=10 imps) times 4 = 40 positive imps for making 4 vulnerable games and losing 6 imps 6 times = (minus 140 plus minus 100 =240=6imps) = only 36 negative imps for going down in game!
